RESOLUTION NUMBER R-268429

ADOPTED ON MAY 11, 1987

WHEREAS, a Jitney Task Force was formed to review and analyze the jitney industry and the further regulation thereof in the interest of the public welfare and safety; and

WHEREAS, the Jitney Task Force has not yet issued a report concerning the jitney industry and the number of permits to be issued, consistent with the needs of the public welfare and safety; and


WHEREAS, it appears that a limit on the number of jitney permits to be issued may be an important factor in such regulation; and

WHEREAS, it appears that in the absence of a specific limit any interim issuance of jitney permits may exacerbate the problem for which a solution is being sought; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby directed to withhold the issuance of any additional jitney permits until the Task Force has had an opportunity to report to the Transportation and Land Use Committee and that committee has had the opportunity to forward its recommendations to the full Council.
