RESOLUTION NUMBER R- 268432

WHEREAS, the United States National Governing Bodies (NGB) are responsible for all activities of their respective sport; and

WHEREAS, The City of San Diego has exclusive negotiating rights for one year with the United States Olympic Committee (USOC) to prepare a proposal for USOC training facility and is looking forward to receiving input from the NGB with regard to their requirements for housing, education, vocation, sports medicine and venues so that the City may best prepare their proposal to the USOC and its Site Selection Committee; and

WHEREAS, during the weekend of June 4 through 7, 1987, representatives of the NGB will visit San Diego for a series of informal discussions, interviews and venue tours and receive a first-hand look at our climate and other outstanding amenities of the area; and


WHEREAS, the United States Olympic Training Center Site Ad Hoc Task Force, made up of business and community leaders, is hosting the weekend's events; and

WHEREAS, The City of San Diego, by action of the City Council, is in complete support of the efforts of the Task Force and its goal of designation by the USOC as a year-round Olympic Training Center; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of all its citizens, extends

their welcome to the National Governing Bodies with the hope that  
their stay in San Diego will be most pleasant and informative.
