WHEREAS, Recycal-San Diego was founded by the beverage distribution industry as a nonprofit organization to promote litter abatement and recycling; and

WHEREAS, William A. Qvistgaard, President of Recycal-San Diego has donated \$2,100 on behalf of that organization to the City of San Diego to defray the costs of hire of four young adults to participate in a seven week litter pickup program on the beaches of San Diego; and

WHEREAS, Recycal-San Diego has participated in similar litter abatement programs with the City during the summers of 1985 and 1986; NOW, THEREFORE,


