RESOLUTION NUMBER R- 268447

ADOPTED ON JUN 1 1987

WHEREAS, part of the City of San Diego/Navy land exchange involves approximately 160 acres of City-owned land northerly of State Route 52 in the Tierrasanta area which was acquired at no cost from the Federal Government in 1973 for park and recreation purposes; and

WHEREAS, another parcel of property in the City/Navy land exchange involves the acquisition from the of the approximately 46-acre Hickman Field Athletic Complex; and

WHEREAS, the City proposes to reconvey the above-described 160 acres to the Navy in exchange for a perpetual easement over approximately 75 acres of said site for use by the Police and Fire Departments for a training academy and police pistol range purposes; and

WHEREAS, in order to utilize said approximately 75 acres for said purposes it will be necessary to obtain a waiver or abrogation of the deed restrictions for park and recreation purposes from the United States Department of the Interior; and


WHEREAS, it is proposed that the Hickman Field Athletic Complex be burdened with a restriction that it be utilized for park and recreation purposes to offset the removal of said restriction from the 75-acre parcel; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to request

from the United States Department of the Interior a waiver or abrogation of the deed restrictions on the 160-acre proposed police pistol range/fire training academy property and reimposition of the restrictions on the Hickman Field Athletic Complex site.
