WHEREAS, it is necessary that the City expend substantially all of the proceeds from the recent open space bond issues within three years from the sale of the bonds; and


WHEREAS, in order to expedite the expenditure of funds and the acquisition of open space parcels the City has in the past established priority lists for acquisition; and

WHEREAS, it is proposed to update the priority list and open space acquisition plan for San Diego Open Space Park Facilities District No. 1; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that that open space acquisition plan containing priorities for open space acquisition, a copy of which is on file in the office of the City Clerk as Document No. RR-268455, is hereby approved.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to proceed expeditiously with the acquisition of open space properties in accordance with the acquisition plan in a manner so as to assure the expenditure of the open space bond funds in a timely manner consistent with federal regulations applicable to such bond funds.
