RESOLUTION NUMBER R- 268457

ADOPTED ON JUN 1 1987

WHEREAS, in 1984, the State of California adopted two kinds of enterprise zone laws, the Enterprise Zone Act [AB 40 (Nolan)] and the Employment and Economic Incentive Act [AB 514 (Waters)]; and

WHEREAS, the City Council created the Enterprise Zone Task Force (Task Force) to coordinate City policy regarding these laws; and

WHEREAS, the California Department of Commerce established application procedures in 1985; and

WHEREAS, the Task Force investigated the various qualifying areas under the two laws and, at Council direction, staff prepared applications for an Enterprise Zone under AB 40 for the Southeast and Barrio Logan area, and an Employment Incentive Area (EIA) under AB 514 for San Ysidro; and

WHEREAS, the Commerce Department approved the Enterprise Zone application, but denied the EIA application; and

WHEREAS, the City Manager, in his Report No. 87-207, dated May 1, 1987, recommended that the City not apply for an Employment Incentive Area but instead direct staff to formulate a job development plan in conjunction with the R/UDAT process; and

WHEREAS, the background and discussion of the entire matter is set forth in detail in said City Manager's report; and

WHEREAS, the Rules Committee reviewed City Manager's Report No. 87-207 at its regularly scheduled meeting of May 6, 1987 and approved the recommendation set forth therein by a 3-0 vote; and

WHEREAS, the matter is now forwarded to the full Council for approval for appropriate action thereon; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager and appropriate staff be and they are hereby directed to formulate a job development plan in conjunction with the R/UDAT process instead of applying for an Employment Incentive Area for the San Ysidro/Otay Mesa area, pursuant to the recommendation set forth in City Manager's Report No. 87-207, dated May 1, 1987.
