
WHEREAS, The City of San Diego is desirous of improving its boating safety and law enforcement program; and

WHEREAS, the State of California, Department of Boating and Waterways is offering the usage of a Boston Whaler boat to The City of San Diego for ten (10) years as a boating safety and law enforcement patrol boat, conditioned on the maintenance and operation of the boat by the City at the City's expense; and

WHEREAS, the usage of the boat represents an estimated value to the City of ten thousand dollars (\$10,000.00) and the estimated maintenance cost is one thousand dollars (\$1,000.00) for the first year and five hundred dollars (\$500.00) annually thereafter; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the State of California, Department of Boating and Waterways for the usage of a Boston Whaler patrol boat for a period of ten (10) years under the terms and conditions set forth in the agreement on file in the Office of the City Clerk as Document No. RR-268460.
