
ADOPTED ON JUN 1 1987

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$28,500 from CIP No. 52-383, Fund 18014, Federal Revenue Sharing FY 86, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
