That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Aldo Chiappone	Utilities	\$2,434.76	Mr. Chiappone Plant Maintenance Supervisor with the Metro Division. He suggested the fabrication of a ferric feed pump system for Point Loma and Metro II. Actual savings of \$16,449.21 in maintenance time was realized. This is his full award.
Phillip Stone	Police	\$1,263.37	Mr. Stone is a Lifeguard Sergeant in the Park & Recreation, Coastal Division. He suggested transferring outboard engines used by lifeguards to the Harbor Patrol after one year. This is expected to save \$4,986.24; the difference between the auction price and the sale price of a new engine. This is his full award.
Trent Robertson	Engineering & Development	\$ 802.38	Mr. Robertson is a Drafting Aide in the Records Section. He suggested establishing a card file to allow faster retrieval of curb-to-property line distances. This is expected to save \$5,349.20 in time.
