Robin Glenn	Risk Management	\$471.12	Ms. Glenn was an Intermediate Typist at the time of this suggestion. She suggested using the SAS computer system (letter option) to input rehabilitation notes. This is expected to save \$3,140.80 in time.
Warren Wazny	Utilities	\$381.13	Mr. Wazny is a Wastewater Plant Operator in the Metro Division. He suggested replacing the scum boards with 3" PVC. Actual savings of \$2,540.85 in time has been realized. This is his full award.
Mary Taylor	Attorney	\$320.00	Ms. Taylor was an Intermediate Typist at the time of this suggestion. She suggested establishing of a numbering and color coding system for Attorney's cases. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Dennis Marnell	General Services	\$265.56	Mr. Marnell is a Equipment Mechanic in the Equipment Division. He suggested the modification of the striker plate on the crane carriers. Actual savings of \$530.56 in parts and labor. This is his full award.
