That the MORENA TRANSPORTATION STUDY shall become effective on the date of adoption and shall be used by The City of San Diego as the outline for implementing transportation improvements in the Morena Revitalization area as designated on Zone Map Drawing No. C-714, on file in the office of the City Clerk as Document No. PR-268492-2
