(FSDRIP) MAINTENANCE DISTRICT.



3. The assessments described in Document No. RR-268498, on file in the office of the City Clerk and on file in the office of the Street Superintendent, are hereby confirmed and approved.
4. The modified assessment district map for the "First San Diego River Improvement Project (FSDRIP) Maintenance District," described in Document No. 769522 is hereby approved.

5. The maintenance described in said Resolution of Intention  
is hereby ordered performed.
