

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$50,000 from CIP No. 37-004, Annual Allocation-Minor Improvements to Landfills, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project and authorizing the City Auditor and Comptroller upon

advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
