WHEREAS, the Mexican and American Foundation ("Foundation") was started in Logan Heights in May 1971 when a few people met to discuss the subject of poverty and the deepening feelings of frustration which were turning to resentment against the majority community; and

WHEREAS, that concern led to the first "An Hour in the Barrio," a luncheon where twenty Hispanics were invited to plan what would become the first "An Evening with the Stars;" and

WHEREAS, "An Evening with the Stars" has grown to become an international extravaganza which features prominent individuals from the entertainment, corporate, and public sectors across the nation; and

WHEREAS, today, after sixteen years, the Foundation has experienced phenomenal growth, and sponsors monthly California forum luncheons which bring together 500-800 individuals and also helps promote international relations between Mexico and the United States; and

WHEREAS, the Foundation assists small and minority business people by putting them in contact with corporate America; and

WHEREAS, the Foundation also assists numerous college students through its Careers and Leadership Development Program, giving them valuable work experience in their career fields; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, does hereby proclaim May 8, 1987 to be "Mexican and American Foundation Day" in San Diego.
