

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to negotiate and execute a memorandum of agreement with the County of San Diego and Signal Environmental Systems, Inc. for the establishment of a Steering Committee to oversee a health risk assessment of landfill gas emissions from various City and County landfills funded and conducted by Signal Environmental Systems, Inc., under such terms and conditions as shall allow for the approval of the scope of work and protocols and concurrence in the selection of the study consultants by such Steering Committee.

BE IT FURTHER RESOLVED, that the Quality of Life Board or its designates acting on its behalf, be and it is hereby authorized to participate in such Steering Committee, together with such other agencies or committees as may be designated by the County of San Diego, and to take a principal role in overseeing the health risk assessment to be conducted.
