RESOLUTION NUMBER R- 268555

ADOPTED ON JUN 09 1987

WHEREAS, on June 23, 1986, the City Council by Resolution Number 266066 authorized the City Manager to administratively abate by demolition the residential premises located at 6365 Shaules Avenue, San Diego, California more particularly described as:

The North Half of Lot Six, in Block J, of the Subdivision of Block H, and Lots 26 to 38 inclusive in Block G of Encanto Heights, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 1170, filed in the office of County Recorder of San Diego County, March 6, 1909.

and

WHEREAS, the City Manager incurred total administrative and actual expenses of \$3,050 to hire a contractor to demolish the structures at 6365 Shaules Avenue and remove all associated debris; and


WHEREAS, a record of the costs of all demolition and administrative work has been reviewed by the City Council; and

WHEREAS, the City Council pursuant to San Diego Municipal Code § 98.0121 has reviewed the record of the costs transmitted by the City Manager and has provided the opportunity for anyone interested in the above described property to contest the total abatement costs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby confirms the cost of abatement of the property at 6365 Shaules Avenue at \$3,050 and a special assessment in the amount of \$3,050 be levied against the above described property.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to collect this special assessment and provide proper documentation to the County Auditor before July 1, 1987, to incorporate this assessment on the municipal tax bill for this property to be collected in the same manner as ordinary municipal taxes, pursuant to Government Code §§ 38773 and 38773.5.
