RESOLUTION NUMBER R- 268556

ADOPTED ON JUN 09 1987

WHEREAS, on April 28, 1986, the City Council by Resolution Number 265575 authorized the City Manager to administratively demolish the structures located at 233 South 32nd Street, San Diego, California more particularly described as:

All of Lots 25 and 26, Block 346,
Subdivision of Block Nine of CENTRAL
HOMESTEAD Addition according to Map
thereof No. 290 filed in the office of
the County Recorder of said San Diego
County, July 14, 1884, EXCEPTING therefrom
the North 97.5 feet;

and

WHEREAS, the City Manager incurred total administrative and actual expenses of \$3,100 to hire a contractor to demolish the structures at 233 South 32nd Street and remove all associated debris; and

WHEREAS, a record of the costs of all demolition and administrative work has been reviewed by the City Council; and


WHEREAS, the record owner of the above-described property is deceased and no heirs could be located or found by the Public Administrator in control of her affairs; and

WHEREAS, the City Council pursuant to San Diego Municipal Code § 98.0121 has reviewed the record of the costs transmitted by the City Manager and has provided the opportunity for anyone interested in the above described property to contest the total abatement costs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby confirms the cost of abatement of the property at 233 South 32nd Street at \$3,100 and a special assessment in the amount of \$3,100 be levied against the above described property.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to collect this special assessment and provide proper documentation to the County Auditor before July 1, 1987, to incorporate this assessment on the municipal tax bill for this property to be collected in the same manner as ordinary municipal taxes, pursuant to Government Code §§ 38773 and 38773.5.
