BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for MOUNTAIN VIEW NEIGHBORHOOD PARK PICNIC SHELTER, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on June 22, 1987, and bearing official Document No. W.O. 118554, be and the same are hereby approved.

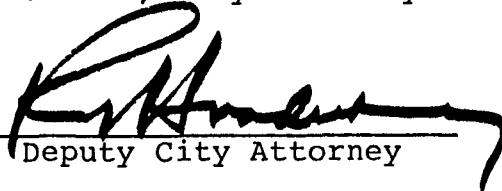
BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for MOUNTAIN VIEW NEIGHBORHOOD PARK PICNIC SHELTER.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$21,540 from Park Service District Fund No. 15660 to CIP No. 29-531 MOUNTAIN VIEW NEIGHBORHOOD PARK - PICNIC SHELTER.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$86,000 (\$21,540 from CIP No. 29-531 MOUNTAIN VIEW NEIGHBORHOOD PARK - PICNIC SHELTER; \$382 from Park Service District Fund No. 11661; \$10,000 from Park Service District Fund No. 11664; \$9,078 from Park Service District Fund No. 11665; and \$45,000 from Revenue Sharing Fund No. 18013) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
