

RESOLUTION NUMBER R- 268568

ADOPTED ON JUN 22 1987

APPROVING MAP OF HALCYON WEST.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Don Nasland, Licensed Land Surveyor, entitled "HALCYON WEST being a subdivision of a portion of Parcel 1 of Parcel Map No. 14439, in the City of San Diego, County of San Diego, State of California, together with a portion of Carmel Country Road, as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: portions of Carmel Country Road, and Townsgate Drive, together with a pedestrian and non-motor vehicular right of way, and said portion(s) of street(s) and pedestrian and non-motor vehicular right of way are hereby declared to be portion(s) of public street(s) and pedestrian and non-motor vehicular right of way, and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Carmel Country Road, adjacent and contiguous to Lots 1, 2 and 13 through 17, all as shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the easement(s) with the right of ingress and egress for the construction and maintenance of water, sewer, drainage and general utility facilities, as granted and shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the building restricted easement(s) over, upon or across Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16 and 17, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion(s) of street(s) and pedestrian and non-motor vehicular right of way are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the easement(s) with the right of ingress and egress for the construction and maintenance of water, sewer, drainage and general utility facilities, and the building restricted easement(s), all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
