APPROVING MAP OF VIEW RIDGE UNIT NO. 7.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That said Council hereby finds that certain map surveyed by Hans Peter Craig, Licensed Land Surveyor, entitled "VIEW RIDGE UNIT NO. 7 being a subdivision of a portion of Quarter Section Lot 52 of Rancho de la Nacion, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 166 by Morrill filed in the office of the County Recorder of San Diego County May 11, 1869," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Aquamarine Road, Anthracite Way, Scarlet Way and Terra Cotta Road, and said street(s) are hereby declared to be public street(s) and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, the easement(s) with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on the map within the subdivision.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street(s) are accepted on behalf of the public as heretofore stated; together with the easement(s) with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
