RESOLUTION NUMBER R- **268596**

ADOPTED ON JUN 22 1987

WHEREAS, The City of San Diego is the owner of Site 214, being portions of Lots 11, 12 and 13, and all of Lot 14, Block 6, Florence Heights Addition; and

WHEREAS, the City desires to negotiate the sale of said land to CANYONVIEW PARTNERS, a limited partnership, the adjacent owner, under the provisions of Section 22.0902 of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the value of the property to be conveyed by the City, as determined by staff appraisal on April 22, 1987, is TWENTY THOUSAND DOLLARS (\$20,000); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That that certain real property described in that grant deed on file in the office of the City Clerk as Document No. RR- **268596**, be, and the same is hereby authorized to be sold by negotiation for the amount of TWENTY THOUSAND DOLLARS (\$20,000) to CANYONVIEW PARTNERS, a limited partnership.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 268536 granting to CANYONVIEW PARTNERS, a limited partnership, the adjacent owner, all those portions of Lots 11, 12 and 13, and all of Lot 14, Block 6, Florence Heights Addition, as more particularly described in said grant deed.

3. That no broker's commission shall be paid by The City of San Diego on the herein described negotiated sale.

4. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
