BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$50,000 within the Sewer Revenue Fund (41506), from the Unallocated Reserve (70697) to the Sewer Operation Engineering Program (70820).

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$50,000 from the Water Operating Fund (41500), Water Operation Engineering Program (70830) and \$50,000 from the Sewer Revenue Fund (41506), Sewer Operation Engineering Program (70820), is hereby authorized, solely and exclusively for the

purpose of providing funds for the above project, and authorizing the Auditor and Comptroller, upon advice from the Administering Department to transfer funds, if any to the appropriate reserve.
