

WHEREAS, it is desired to extend the term of said agreement for an additional year until June 30, 1988, under the same terms and conditions; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Personnel Director be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Second Amendment to the Agreement with Industrial Medical Centers, a copy of which is on file in the office of the City Clerk as Document No. RR- 268616, to extend for a period of one year, until June 30, 1988, the agreement to provide preemployment physical examination and other additional medical services, under the same terms and conditions of the extended agreement on file in the office of the City Clerk as Document No. RR-263841.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend all necessary funds that are appropriated and allocated for said purposes.
