RESOLUTION NUMBER R- 268627

ADOPTED ON JUN 22 1987

WHEREAS, there exists in the City of San Diego a need for standard housing units affordable to lower income families; and

WHEREAS, there exists thousands of rental properties which could be rehabilitated to help meet this need; and

WHEREAS, the City of San Diego has recognized this and undertaken programs to help meet this need; and


WHEREAS, Federal funds in the amount of \$1,185,000 have been made available to the City of San Diego to rehabilitate rental properties in order to increase the supply of standard housing units affordable to lower income families; and

WHEREAS, the San Diego Housing Commission is currently implementing such a program designed to rehabilitate rental units for low income families; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council approves the Rental Rehabilitation Application and Program Description, copies of which are on file in the office of the City Clerk as Document No. RR- 268627 and delegates to the San Diego Housing Commission authority to implement this program.

BE IT FURTHER RESOLVED, that the City Manager is authorized to execute any necessary documents, including the concomitant Section 8 Annual Contributions Contract.
