
RESOLUTION NUMBER R- 268654

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO, a public body, corporate and politic, executed in favor of The City of San Diego, bearing date of March 16, 1987, a copy of which deed is on file in the Office of the City Clerk as Document No. RR-268654 granting to said City an easement for public street purposes in a portion of Lots 11-13, Block 6, Map No. 419, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named "F" STREET.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
