RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
SAN DIEGO, CALIFORNIA, AWARDING THE CONTRACT  
FOR THE CONSTRUCTION OF CERTAIN PUBLIC WORKS  
OF IMPROVEMENT IN A SPECIAL ASSESSMENT  
DISTRICT.

(Assessment District No. 4007 - First San Diego River  
Improvement Project (FSDRIP))

WHEREAS, the City Council of the City of San Diego,  
California, did publicly open, examine and declare all sealed  
proposals or bids for doing the work and improvements described  
in its Resolution of Intention, which Resolution and a "Report"  
subsequently approved are hereby expressly referred to for a  
description of said work and improvements and for all particulars  
relative to the proceedings for the works of improvement, in a  
special assessment district known and designated as ASSESSMENT  
DISTRICT NO. 4007 - FIRST SAN DIEGO RIVER IMPROVEMENT PROJECT  
(FSDRIP) (hereinafter referred to as the "Assessment District");  
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as  
follows:

SECTION 1. That the above recitals are all true and correct.

SECTION 2. That the City Council hereby rejects all of said  
proposals or bids except that herein mentioned, and does hereby

award the construction contract, for the Base Bid and Additive Alternate No. 2 only, for doing said work and making improvements in the Assessment District to the lowest responsible bidder, to-wit: CHILCOTE, INC. at the prices named in the bid of said bidder with the transcript of these proceedings and open for public inspection.

SECTION 3. That this award of contract is hereby conditioned upon and made subject to the receipt of monies and proceeds from the sale of bonds. The Contractor shall not commence construction or order equipment until he has received a notice to proceed. Any progress payment to the Contractor for work completed may be delayed in monies have not been received from the sale of bonds.

SECTION 4. That the works of improvement shall be constructed in the manner and form as set forth in the plans and specifications for these proceedings, as previously approved as a part of the Report as required by law and specifically the "Municipal Improvement Act of 1913," being Division 12 of the Streets and Highways Code of the State of California.

SECTION 5. That the works of improvement for the above-referenced Assessment District shall be paid from funds in the Improvement Fund, together with any interest earned on said Fund.


SECTION 6. That the City Manager is hereby authorized to execute the Agreement for the works of improvement relating to
