WHEREAS, the San Diego Private Industry Council is sponsoring a campaign to encourage employers to place youth aged 14 to 21 in jobs as part of a national concern for youth unemployment; and

WHEREAS, this effort is a joint venture of the County of San Diego, the State Job Service, the Policy Board of the San Diego Regional Employment and Training Consortium and other agencies involved in the training of youth for employment; and

WHEREAS, the need for jobs for youth is particularly acute, especially during the summer months; and

WHEREAS, our youth is the workforce of tomorrow and their employment benefits the community; and

WHEREAS, employers may receive federal and state tax credits for hiring youth; and


WHEREAS, The City of San Diego desires to stress its responsiveness to the needs of youth in the community; NOW, THEREFORE,
