BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for SEISMIC RETROFITTING OF MISSION BAY DRIVE BRIDGE OVER ROSE CANYON CREEK, CONTRACT #1.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$86,530 from Capital Outlay Fund 30245, CIP No. 53-037 ANNUAL ALLOCATION - EARTHQUAKE RESTRAINERS FOR BRIDGES is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
