

RESOLUTION NUMBER R- 268693

ADOPTED ON JUN 29 1987

WHEREAS, the annual salary ordinance [O-16867, (New Series)] provides for rate and step adjustments for and during any fiscal year by the appointing authority; and

WHEREAS, the salaries of the several executive positions which are set by the City Council are set forth in Exhibit CC of the salary ordinance; and

WHEREAS, these changes are effectuated by payroll change notice [PCN] initiated and processed by the Mayor; and

WHEREAS, this method of executing said adjustments to compensation is an established practice of many years; and

WHEREAS, it is appropriate at this time for the Council to again express its cognizance of and memorialize this process and authorize the Mayor to initiate and submit PCNs for those positions called out and identified in the annual salary ordinance, pursuant to the terms thereof; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor of The City of San Diego be and she is hereby authorized to act as the appointing authority for the purpose of initiating and processing necessary payroll change notices effectuating salary adjustments, as established in the salary

ordinance and during fiscal year 1988, for those executive positions identified in the annual salary ordinance for said fiscal year 1988.
