BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Joint Powers Agreement with the County of San Diego, to conduct a landfill siting search, under the terms and conditions set forth in the Joint Powers Agreement on file in the office of the City Clerk as Document No. RR- 268695 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$90,000 from General Services Department, Refuse Disposal Division, Fund 100, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project and authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
