
WHEREAS, 120 antique and classic cars representing the largest racing collection of America's automotive heritage will roll into Seaport Village in downtown San Diego where they will go on display for free public viewing; and

WHEREAS, The City of San Diego will receive national recognition and attention not only as a first-day race destination, but also as a result of the entry of the 1931 Cadillac roadster owned by Jim Chaffee representing San Diego, which he has named the "Spirit of San Diego;" NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of said City, does hereby extend an official welcome to the Great Race participants and congratulate them for the fortitude and stamina required in the demanding and unparalleled 3,660 mile test of man and antique machines.

BE IT FURTHER RESOLVED, that Tuesday, June 30, 1987, be proclaimed as "Great American Race Day" in San Diego and that all San Diego citizens are urged to observe the occasion and event.
