WHEREAS, the CITY-WIDE LANDSCAPE REGULATIONS are a part of The City of San Diego's Local Coastal Program Implementing Ordinances; and

WHEREAS, on March 10, 1987, the City Council approved the Local Coastal Program Implementing Ordinances, including the CITY-WIDE LANDSCAPE REGULATIONS; and

WHEREAS, the proposed amendments to the CITY-WIDE LANDSCAPE REGULATIONS, as set forth in Attachment 1 of Planning Report No. 87-269, would delete and supercede the specific coastal zone regulations (Section 101.0704, paragraph G.), approved by the City Council on March 10, 1987; and


WHEREAS, the landscaping coverage requirements contained in the proposed amendments to the CITY-WIDE LANDSCAPE REGULATIONS will exceed the requirements approved specifically for the Coastal Zone; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That this Council approves the proposed amendments to the CITY-WIDE LANDSCAPE REGULATIONS, subject to final and effective certification by the California Coastal Commission.

2. That this Council authorizes the submission of Ordinance No. 0-16892(New Series), the CITY-WIDE LANDSCAPE REGULATIONS amendments, to the California Coastal Commission for final and effective certification.
