APPROVING MAP OF PENASQUITOS PARK
VIEW ESTATES UNIT NO. 13.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Robert G. Schoettmer, Licensed Land Surveyor, entitled "PENASQUITOS PARK VIEW ESTATES UNIT NO. 13 being a subdivision of a portion of the Rancho los Penasquitos, in the City of San Diego, County of San Diego, State of California, according to map accompanying the patent to said Rancho recorded in the office of the County Recorder of San Diego County, in Book 2, Page 385 of Patents," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Park Village Road, Least Tern Court, Celome Way, Celome Lane and Celome Court, and said street(s) are hereby declared to be public street(s) and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby rejects as a dedication those portions of Lots 61, 62 and 63, marked "Reserved for Future Streets," as shown on the map, under the provisions of Government Code Section 66440.

That said Council hereby accepts on behalf of The City of San Diego, the easement(s) with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on the map within the subdivision.


That said Council hereby accepts on behalf of The City of San Diego, the open space easement(s) over, upon or across all those portions of Lots 30 through 56, inclusive, and 59, 60, 61 and 62, as set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street(s) are accepted on behalf of the public as heretofore stated; that said Council has rejected a portion of Lots 61, 62 and 63 marked "Reserved for Future Streets," together with the easement(s) with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, and the open space easement(s), all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
