RESOLUTION NUMBER R- 268768

ADOPTED ON JUL 06 1987

WHEREAS, the San Diego Regional Center (Center), affiliated with the State of California's Department of Developmental Disabilities Services, provides educational and rehabilitative services to developmentally disabled clients attending day programs at various agency sites within the City; and

WHEREAS, Adult Protective Services (APS) offers adult day care services to primarily low-income elderly individuals who might otherwise require institutionalization; and

WHEREAS, many of the Center's and APS's clients are City residents eligible to purchase a limited amount of Dial-a-Ride coupons at a 75% or 85% discount; and

WHEREAS, the Center's program transportation is designed so that several of their clients travel in a single vehicle from various locations to a common destination on a daily basis and the delivery of service in this manner makes the use of coupons by the passenger a cumbersome method of payment; and

WHEREAS, a more effective method would entail a third party billing arrangement among the transportation provider, the City; and

WHEREAS, this agreement would allow the San Diego Regional Center to fund a Dial-a-Ride service:

- (1) at 25% of cost for their clients who are eligible for the City's monthly allocation for taxi trips;

(2) at 15% of cost for clients who are eligible for the City's monthly allocation for wheelchair lift-equipped van services;

(3) at 100% of cost for service to their clients in excess of the City's monthly allocation;


(4) at 100% of cost for service provided to their clients who are not eligible for the City's subsidy;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, agreements with the San Diego Regional Center for the Developmentally Disabled and Adult Protective Services Inc., for the purpose of selling Dial-a-Ride services to their designated clients attending day programs, pursuant to the terms and conditions of the agreements, on file in the office of the City Clerk as Documents No. RR- 268768 -1 [San Diego Regional Center] and Rr- 268768 -2 [Adult Protective Services Inc.].
