WHEREAS, on June 10, 1987, the Public Services and Safety Committee approved the process of entering into an agreement with the Private Industry Council/Regional Employment Training Consortium (PIC/RETC) to provide employment services to the downtown homeless; and


WHEREAS, the City will contribute \$130,000, which will be combined with a PIC/RETC contribution of \$100,000, which will allow for a single subcontract to be awarded to Episcopal Community Services, who was the successful bidder for the program; and

WHEREAS, the joint City/PIC/RETC program will provide casual job placement, preemployment training, on-the-job training, and appropriate supportive services (individual counseling, identification verification, mail and message service, etc.);
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an agreement with the Private Industry Council/Regional Employment Training Consortium (PIC/RETC), for the purpose of performing an Employment Assistant Program for the Downtown Homeless, pursuant to the terms and conditions of the agreement, on file in the office of the City Clerk, as Document No. RR- 268772 .

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby fully authorized to expend the sum of \$130,000 from Fund 18523, Department 5634, Organization 3403, for the purpose of providing the City's contribution to the assistance program, as specifically provided in section 1 of the above-cited agreement.
