RESOLUTION NUMBER R- 268779

ADOPTED ON JUL 07 1987

WHEREAS, on September 20, 1985 the City awarded a valid and binding contract to Carina Engineering for the construction of the Skyview Park; and

WHEREAS, the proposed Skyview Park was to be a recreational asset to the City of great value; and

WHEREAS, Carina Engineering was given a notice to proceed on November 4, 1985; and

WHEREAS, Carina Engineering did commence work in a timely fashion; and

WHEREAS, Carina Engineering has not proceeded to completion of the Skyview Park project; and

WHEREAS, the Skyview Park project remains incomplete while it is now several months past the contracted time for completion of the project; and


WHEREAS, despite repeated attempts by the City Manager, Carina Engineering has failed and/or refused to complete the Skyview Park; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council hereby declares the contract with Carina Engineering for the construction of Skyview Neighborhood Park to be cancelled and the work to be performed thereunder is hereby ordered terminated pursuant to section 6.4 of the Standard Specifications for Public Works Contracts (1982 edition).

BE IT FURTHER RESOLVED, that the City Attorney is hereby directed to recover such costs as may be incurred by the City resulting from Carina Engineering's default under this agreement.

BE IT FURTHER RESOLVED, that based upon the continuing and conscious failure of Carina Engineering to perform its duties under this contract that the City Council hereby finds Carina Engineering to not be a responsible and reliable bidder for the public works of this city.
