WHEREAS, said amendments are consistent with the Progress Guide and General Plan for The City of San Diego; and

WHEREAS, the Planning Commission of The City of San Diego, at a noticed public hearing on May 28, 1987, recommended adoption of the amendments to the OLD SAN DIEGO COMMUNITY PLAN presented in Planning Report No. 87-270 with some modifications which have been incorporated into the draft plan; and

WHEREAS, on July 7, 1987, a public hearing was held before the Council of The City of San Diego where they also duly considered the Community Plan amendments and all pertinent documents; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves the OLD SAN DIEGO COMMUNITY PLAN amendment, a copy of which is on file in the office of the City Clerk as Document No. RR- 268785.
