BE IT RESOLVED, by the Council of The City of San Diego, that the Planning Director is authorized and empowered to adjust fees and deposits associated with processing Planning Director reviews in accordance with Municipal Code Section 101.0204 to be effective on the effective date of O- 16906 (New Series), amending the OLD SAN DIEGO PLANNED DISTRICT, as follows:

1. All submittals for new construction must include a deposit for \$1,750.00.
2. All submittals for rehabilitation of existing development and signs must include a deposit for \$500.00.
3. All submittals for preliminary review must include a deposit of \$500.00 which may be applied to future submittals for final action.
