

RESOLUTION NUMBER R- 268787

ADOPTED ON JUL 07 1987

WHEREAS, in the Fall of 1984, Councilmember Bill Cleator and the Council of The City of San Diego appointed the OLD SAN DIEGO TASK FORCE; and

WHEREAS, the purpose of the Task Force was to consider comprehensively the needs of Old Town and make recommendations to the Council; and

WHEREAS, the members represent the residents of Old Town and Mission Hills, business persons and professionals, and development professionals such as architects and realtors and representatives of many governmental agencies and community group representatives; and

WHEREAS, an executive committee overseeing six subcommittees was formed to analyze six areas of concern: architecture/historical, land use, parking and circulation, public agencies, streetscape and amenities, and marketing and economics; and

WHEREAS, the Task Force has conducted numerous public meetings, including a design workshop; and

WHEREAS, on May 28, 1987, at a noticed public hearing, the Planning Commission reviewed, considered and accepted the Old San Diego Task Force recommendations; and

WHEREAS, on July 7, 1987, at a noticed public hearing, the Council of The City of San Diego also reviewed and considered the Old San Diego Task Force recommendations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby accepts the OLD SAN DIEGO TASK FORCE recommendations, a copy of which is on file in the office of the City Clerk as Document No. R- 268787.
