FURTHER RESOLVED, that the City Manager is hereby BE authorized to execute a contract with the lowest responsible bidder, contingent upon receipt of said Grant Funds in an amount not less than \$303,833 for the CONSTRUCTION OF CLAIREMONT FRIENDSHIP CENTER.

IT FURTHER RESOLVED, that the expenditure, not to exceed \$703,833 from CIP No. 37-205 SENIOR COMMUNITY CENTER (\$303,833 from State Senior Bond Act; \$300,000 from Community Development Block Grant Fund 18521; and \$100,000 from Community Development Grant Fund 18522 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
