- 2. Certifies that the senior center will be available for use by all senior citizens.

- 4. Certifies that said agency has or will have available prior to commencement of any work on the project(s), matching money from a non-federal or non-state source.
- 5. Certifies that said agency will comply with all federal, state, and local environmental, public health, relocation, affirmative action, and clearinghouse requirements and all other appropriate codes, laws and regulations applicable to the project.
- 6. Certifies that the project(s) included in this application conform to the Area Plan on Aging for the Planning and Service Area in which the senior center is located.
- 7. Appoints the City Manager as agent of the City to conduct all negotiations, execute and submit all documents including, but not limited to, applications, agreements, amendments, payment requests, reports, and so forth which may be necessary for the completion of the aforementioned project(s).
