BE IT RESOLVED, by the Council of the City of San Diego that all bids theretofore received on May 21, 1987, for CONSTRUCTION OF WABASH NEIGHBORHOOD PARK IRRIGATION IMPROVEMENTS are hereby rejected.

BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF WABASH NEIGHBORHOOD PARK IRRIGATION IMPROVEMENTS, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on JUL 13 1987, and bearing official Document No. W.O. 118550, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

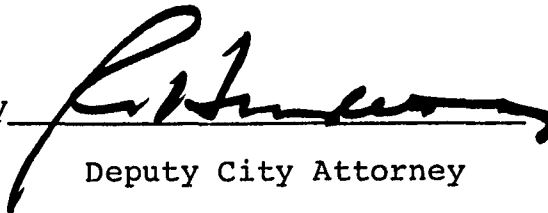

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$27,000 from the Mid City Park Development Fund No. 39094 to CIP No. 29-471 WABASH NEIGHBORHOOD PARK - IRRIGATION SYSTEM.
