RESOLUTION NUMBER R- 268802

APPROVING MAP OF CAMINO BERNARDO UNIT NO. 4.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Robert G. Schoettmer, Licensed Land Surveyor, entitled "CAMINO BERNARDO UNIT NO. 4 being a subdivision of a portion of Parcel 2 of Parcel Map No. 11645, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of said County September 9, 1981, together with Avenida Abeja and Avenida De Los Lobos as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Camino Codorniz, Corte Codorniz, Camino Armilla, Camino Abrojo, Corte Lagarto, Avenida De Los Lobos and a portion of Avenida Abeja, and said street(s) and portion(s) of street(s) are hereby declared to be public street(s) and portion(s) of public street(s) and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


That said Council hereby rejects as a dedication a portion of Lot 45, marked "Reserved for Future Streets," as shown on the map, under the provisions of Government Code Section 66440.

That said Council hereby accepts on behalf of The City of San Diego, the open space easement(s) over, upon or across all of Lots 46, 47, 48 and 49, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street(s) and portion(s) of street(s) are accepted on behalf of the public as heretofore stated; that said Council has rejected a portion of Lot 45 marked "Reserved for Future Street"; and the open space easement(s), all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
