BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Robert G. Schoettmer, Licensed Land Surveyor, entitled "CAMINO BERNARDO UNIT NO. 7 being a subdivision of a portion of Parcel 2 of Parcel Map No. 11645, in the City of San Diego, County of San Diego, State of California, according to map thereof filed in the office of the County Recorder of said County September 9, 1981," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Camino Codorniz, Camino Abrojo and Corte Calandria, and said street(s) are hereby declared to be public street(s) and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, the open space easement(s) over, upon or across all of Lots 40 and 41, as granted and shown on the map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the
