
RESOLUTION NUMBER R- 268818

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of GUARANTY SERVICE CORPORATION, a Texas corporation, and COSTA VERDE ASSOCIATES, an Indiana limited partnership, executed in favor of The City of San Diego, bearing dates of April 13, 1987, and April 15, 1987, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 268818, granting to said City easements for public street purposes in those portions of Pueblo Lots 1301, 1302 and 1308 of the Pueblo Lands of San Diego, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named ESPLANADE COURT, GENESEE AVENUE, NOBEL DRIVE, COSTA VERDE BOULEVARD, PLAZA DE PALMAS, LA JOLLA VILLAGE DRIVE AND REGENTS ROAD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
