RESOLUTION NUMBER R- 268823

WHEREAS, on May 8, 1987, the Public Facilities and Recreation Committee considered City Manager's Report No. 87-239 entitled "City-owned Land Designated for Sale" and approved the following recommendations:

1. Redesignate for other uses, per the City Manager's recommendations, those sites set out in Attachment A thereof entitled "Exclusive Sale Sites Previously Designated for Sale by Council which Individual Councilmembers Suggest be Redesignated."
2. Reaffirm for sale the balance of the exclusive sale sites set out in Attachment B entitled "Exclusive Sale Sites Previously Designated for Sale by Council to be Reaffirmed for Sale," and direct the City Manager to proceed with their sale by exclusive sale to the adjacent owner.
3. That the Council annually review the list of exclusive sale sites designated for sale and that approval be sought from the appropriate Council Committee immediately prior to commencing sale negotiations;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the above recommendations of the Public Facilities and Recreation Committee are hereby approved and the City Manager is directed to proceed with regard to "exclusive sale" of City-owned land designated for sale in connection with said recommendations.


