RESOLUTION NUMBER R- 268828

ADOPTED ON JUL 13 1987

WHEREAS, the COLLEGE AREA COMMUNITY COUNCIL (herein "Planning Group") was recognized by the City Council as the official community planning committee for the State University Area planning area on June 1, 1971 through the passage of Resolution No. 202846; and

WHEREAS, the Planning Group's bylaws were most recently revised by the City Council on June 2, 1986 in order to assure compliance with Council Policy 600-24; and


WHEREAS, the Planning Group has amended its bylaws to establish a fourth condition whereby an Executive Board vacancy exists, redefine deadlines for eligibility for election to the Executive Board, define the membership year, change the deadline for payment of voluntary dues, and establish a procedure to recall an Executive Board member; and

WHEREAS, the recommended amendments were reviewed and adopted unanimously by the Rules Committee on May 20, 1987 and are now forwarded to the full Council for appropriate action; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation contained in Planning Department Report No. 87-236, dated May 13, 1987, to adopt the amended bylaws for the COLLEGE AREA COMMUNITY COUNCIL, a copy of which is on file in the office of the City Clerk as Document No. RR- 268828, be and the same is hereby approved.
