

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer within Capital Outlay Fund 30245 an amount not to exceed \$35,000 from CIP No. 52-353.0, Eighth Avenue Railroad Crossing to CIP No. 52-313.0, Whittier Street.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$83,500 from Capital Outlay Fund 30245, CIP No. 52-313.0, Whittier Street, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
