RESOLUTION NUMBER R- 268840

ADOPTED ON JUL 13 1987

WHEREAS, San Diego Bay is a unique and vital resource to all residents of southern California; and

WHEREAS, recent studies of chemical contamination in San Diego Bay indicate sufficient quantities to raise concerns regarding the long-term effects on marine life; and

WHEREAS, the State Water Resources Control Board, through the San Diego Regional Water Quality Control Board (herein "Board"), has provided funding for a program of research and monitoring of pollution problems in San Diego Bay; and

WHEREAS, present law does not assign water quality assurance in San Diego Bay to any one agency; and

WHEREAS, as a means to smooth problems related to multi-agency jurisdiction and provide for the early identification of potential toxic problems in San Diego Bay, the proposed legislation, as amended, would create the "San Diego Bay Water Quality Advisory Committee" (herein "Committee"); and

WHEREAS, the Committee would provide technical and advisory input into the study being conducted by the Board; and

WHEREAS, the Committee would consist of sixteen governmental agencies that have jurisdiction over various activities involving San Diego Bay as well as other interested users; and

WHEREAS, as amended on May 13, 1987, the Committee would have an executive committee to guide and do the major work of the panel; and

WHEREAS, AB 158 (Killea) proposes legislation to remedy this situation; and

WHEREAS, the Intergovernmental Relations Department has provided a complete discussion of the matter and concurrent recommendations in its Report No. 87-14, dated May 29, 1987; and

WHEREAS, the matter is now presented to Council for appropriate action on said recommendations contained in IRD Report No. 87-14; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council expresses its support for AB 158 (Killea), as amended on May 28, 1987, as recommended in IRD Report No. 87-14, which establishes the San Diego Bay Water Quality Advisory Committee, provided it is amended to:

1. Expand the Executive Committee of the Advisory Committee from six to nine positions; and
2. Delete section 2.b.(4) requiring a majority vote of the Executive Committee to approve agency/group nominees for membership on the advisory committee.
