BE IT FURTHER RESOLVED, that the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed, a copy of which is on file in the office of the City Clerk as Document No. RR-268844, conveying to CONTRACT SYSTEMS, INC. (CSA), all of Lot 5, South San Diego Industrial Park, upon payment by CSA of the required purchase price of \$615,000.
